

# What would you do with another \$2600?

If your household makes less than \$57,000 per year, you likely qualify for tax credits. The catch? You can't get the credit as a refund if you don't file your taxes. But don't worry — you are eligible to get free tax preparation by trained professionals. **Volunteer Income Tax Assistance (VITA) and local non-profits are working together to make free filing easy for you.**

## Two Ways to File: Virtual and Valet VITA Sites

You can submit your tax documents to our mobile-friendly site without leaving the house. Use the camera on your phone, tablet, or computer and upload your documents to [getyourrefund.org/tulsa](https://getyourrefund.org/tulsa). Your documents will be processed by a certified tax preparer who will contact you to verify and approve your refund.

## What do you need to file your taxes?

### Identification

- Photo ID: Driver's License, State ID, for yourself and spouse if applicable
- Social Security cards for yourself, spouse, and each dependent, or ITIN.
- Birthdates for you, your spouse and dependents

### Income Statements or Forms (all that apply)

- Wage and earning statement(s) Form W-2, W-2G, 1099-R, 1099-Misc from all employers
- Interest and dividend statements from banks (Forms 1099)
- A copy of last year's federal and state returns (if available)

### Proof of Expenses

- Mortgage interest (Form 1098)
- Student loan interest statements (Form 1098-E)
- Medical/HMO premiums paid for self & family members
- Total paid for daycare provider & daycare provider's tax ID number if appropriate

### Getting Your Return

- If you want to receive your refund by direct deposit, proof of bank account routing numbers and account numbers such as a voided check
- To file taxes electronically on a married-filing-joint tax return, both spouses must be present to sign the required forms.
